The Public Diplomacy Section of the U.S. Department of State at U.S. Embassy Warsaw and Consulate General Krakow (PD Poland) is pleased to announce that funding is available through its Public Diplomacy Grant Program. This is an Annual Program Statement, outlining our funding priorities, the strategic themes we focus on, and the procedures for submitting requests for funding. Please carefully follow all instructions below.

Funding Instrument Type: Grant, fixed amount award (FAA), or cooperative agreement. Cooperative agreements and some FAAs are different from grants in that bureau/embassy staff are more actively involved in the grant implementation ("Substantial Involvement").

Program Performance Period: Proposed projects should be completed in 18 months or less. PD Poland will entertain applications for continuation grants funded under these awards beyond the initial budget period on a non-competitive basis subject to availability of funds, satisfactory progress of the program, and a determination that continued funding would be in the best interest of the U.S. Department of State. **This notice is subject to availability of funding.**

2. Executive Summary

PD Poland is pleased to announce that funding is available through its Public Diplomacy Grant Program. This is an Annual Program Statement, outlining our funding priorities, the strategic themes we focus on, and the procedures for submitting requests for funding. Please carefully follow all instructions below.

B. Eligibility

1. Eligible Applicants

The following organizations are eligible to apply:

- Appropriately registered not-for-profit organizations, including think tanks and civil society/non-governmental organizations with programming experience;
- Individuals to include alumni of U.S. government sponsored exchange programs;
 and
- Non-profit or governmental educational institutions including public libraries, schools, and universities.

For-profit or commercial entities are not eligible to apply.

To be eligible for consideration, <u>the applicant organization must be registered to operate in Poland</u>, or if this is not the case, they are strongly encouraged to <u>partner with a local Polish organization registered to operate in Poland</u>.

2. Cost Sharing or Matching

Cost sharing is allowed but <u>not required</u> and will not affect funding decisions.

3. Other Eligibility Requirements

All organizations must have a Unique Entity Identifier (UEI) issued via SAM.gov as well as a valid registration on SAM.gov. Please see Section E.3 for more information. Individuals are not required to have a UEI or be registered in SAM.gov.

Applicants are only allowed to submit one proposal per organization. If more than one proposal is submitted from an organization, all proposals from that institution will be considered ineligible for funding.

C. Program Description

1. Goals and Objectives

PD Poland invites proposals for programs that strengthen ties between the United States and Poland through activities that , and forge enduring connections between the United States and emerging Polish leaders (high school students, university students, and young professionals ages 15 to 35), as well as established professionals in the public, private, and nonprofit sectors. All proposals are required to have a clear connection to the United States, either through U.S. organizations, experts, and/or best practices in order to increase the awareness and understanding of U.S. perspectives, policies, and society.

Proposals without significant U.S. content will not be considered for funding.

Examples of possible public diplomacy grant activities include, but are not limited to:

- Participatory and/or problem-solving workshops like "tech camps."
- Seminars, trainings, master classes, and exhibitions on themes or topics that advance shared prosperity, innovation, and security goals, as well as build leadership skills.
- Programs that reinforce and amplify lessons learned by Polish alumni of U.S.
 Government-funded and private sector exchange programs.
- Follow-up programs that build on the knowledge and skills developed through previous USG-funded initiatives.

Priority Program Areas:

ECONOMIC PROSPERITY

- Strengthening the business skills of young entrepreneurs based on U.S. experiences and best practices.
- Sharing best practices of U.S. businesses operating in Poland.
- Promoting the development of trade and investment with the United States as the basis for strong, sustainable economic growth that creates jobs and business expansion.

INNOVATION

 Promoting a culture of innovation in science, space, and other technology sectors through U.S. – Polish collaboration among research organizations, nongovernmental organizations, universities, and private companies.

ENSURING SECURITY

• Demonstrating the benefits of the Polish-U.S. security partnership and NATO Alliance for Polish emerging leaders (high school and university students ages 15-25 and/or young professionals ages 25-34).

- Enhancing public awareness of the economic and security benefits of U.S. Poland energy sector cooperation.
- Strengthen cyber security awareness.
- Promoting energy security.

LEADERSHIP

Leadership training inspired by U.S. experiences, models, and best practices to
provide young people (high school students, university students, young
professionals) the skills and knowledge they need to become effective leaders in
their communities and professional field of choice. This includes skills-building
workshops such as public speaking, critical thinking, financial literacy, and
problem-solving, enriched by American know-how and exposure to innovative U.S.
approaches.

Participants and Audiences:

Proposals should describe both the primary and secondary audiences for the program, including anticipated numbers to be reached. Primary audiences are those who will participate directly in the program, while secondary audiences are those who will be reached by the project's primary audiences as a result of their participation. Priority target audiences in Poland for this funding opportunity are youth (high school students, university students ages 15-25) and young professionals (up to 35 years old) who have demonstrated strong leadership potential as well as established professionals engaged in fields relevant to the U.S.-Polish partnership, and community leaders.

The following types of programs are NOT eligible for funding:

- Programs relating to partisan political activity;
- Charitable or development activities;
- Construction programs;
- Programs that support specific religious activities;
- Fund-raising campaigns;
- Lobbying for specific legislation or programs;
- Scientific research;
- Programs intended primarily for the growth or institutional development of the organization; or
- Programs that duplicate existing programs.

This funding opportunity aims to support specific projects with objectives that can be achieved within a set timeframe. We will not accept applications that are aimed more broadly at supporting your organization's usual or typical daily activities and operations. Those will be deemed <u>technically ineligible</u> and will not be considered for funding by the review committee.

2. Substantial Involvement

Awards issued under this notice may be made as a Grant, Fixed Amount Award (FAAs), or Cooperative Agreement, depending on the nature of the activity. Cooperative Agreements and some FAAs are different from grants in that PD Poland staff are actively involved in program activities beyond routine monitoring, i.e., "substantial involvement." The appropriate instrument may vary depending on the nature of the project proposed and will be determined during pre-award negotiations with successful applicants. Examples of "substantial involvement" include the review and approval of program modifications, such as project locations, participant numbers, implementing organizations, or program structure; provision of guidance and concurrence on participant outreach, recruitment, and selection; and a review of implementing organizations' program descriptions and program plans/schedules.

D. Application Contents and Format

<u>Please follow all instructions below carefully.</u> Proposals that do not meet the requirements of this announcement or fail to comply with the stated requirements will be ineligible.

Content of Application

Please ensure:

- The proposal clearly addresses the goals and objectives of this funding opportunity
- All documents are in English
- All budgets are in U.S. dollars
- All pages are numbered
- All Microsoft Word documents are single-spaced, 12-point font, with a minimum of 1-inch margins.

2. Summary Page

Cover sheet stating the applicant name and organization, proposal date, program title, program period proposed start and end date, and brief purpose of the program.

3. Proposal (5 pages maximum)

The proposal should contain sufficient information that anyone not familiar with it would understand exactly what the applicant wants to do. We highly recommend that applicants use the proposal template provided here. If you choose not to use the template provided, you may use your own proposal format, but it must include all the items below.

- **Proposal Summary:** Short narrative that outlines the proposed project, including project objectives and anticipated impact.
- Introduction to the Organization or Individual applying: A description of past and present operations, showing ability to carry out the program, including information on all previous grants from the U.S. Embassy and/or U.S. government agencies.
- **Problem Statement:** Clear, concise and well-supported statement of the problem to be addressed and why the proposed program is needed
- **Program Goals and Objectives:** The "goals" describe what the program is intended to achieve. The "objectives" refer to the intermediate accomplishments on the way to the goals. These should be achievable and measurable.
- **Project Activities**: Describe the program activities and how they will help achieve the objectives.
- **Project Methods and Design**: A description of how the program is expected to work to solve the stated problem and achieve the goal. Include a logic model as appropriate.
- **Proposed Project Schedule and Timeline:** The proposed timeline for the program activities. Include the dates, times, and locations of planned activities and events.
- **Key Personnel:** Names, titles, roles and experience/qualifications of key personnel involved in the program. What proportion of their time will be used in support of this program?
- **Project Partners:** List the names and type of involvement of key partner organizations and sub-awardees.
- **Project Monitoring and Evaluation Plan:** This is an important part of successful grants. Throughout the time-frame of the grant, how will the activities be monitored to ensure they are happening in a timely manner, and how will the program be evaluated to make sure it is meeting the goals of the grant?
- **Future Funding or Sustainability:** Applicant's plan for continuing the program beyond the grant period, or the availability of other resources, if applicable.

4. Budget Justification Narrative

After filling out the SF-424A Budget (above), use a separate file to describe each of the budget expenses in detail. See section *I. Other Information: Guidelines for Budget Submissions* below for further information.

3. Unique entity identifier and System for Award Management (SAM.gov) Required Registrations

All organizations, whether based in the United States or in another country, must have a Unique Entity Identifier (UEI) and an active registration with the SAM.gov. A UEI is one of the data elements mandated by Public Law 109-282, the Federal Funding Accountability and Transparency Act (FFATA), for all Federal awards. An applicant must maintain an active registration while it has a proposal under review by the Department and must continue to keep the registration active for the entire duration of the period of performance of any Federal award that results from the NOFO.

The 2 CFR 200 requires that subrecipients obtain a UEI. Please note the UEI for subrecipients is not required at the time of application but will be required before an award is processed and/or directed to a subrecipient.

Note: The process of obtaining or renewing a SAM.gov registration may take anywhere from 4-8 weeks. <u>Please begin your registration as early as possible</u>.

 Organizations based in the United States or that pay employees within the United States will need an Employer Identification Number (EIN) from the Internal Revenue Service (IRS) and a UEI prior to registering in SAM.gov.

- Organizations based outside of the United States and that do not pay employees
 within the United States do not need an EIN from the IRS but do need a UEI prior to
 registering in SAM.gov.
- Organizations based outside of the United States that do not intend to apply for U.S. Department of Defense (DoD) awards are no longer required to have a NATO Commercial and Government Entity (NCAGE) code to apply for non-DoD foreign assistance funding opportunities. If an applicant organization is mid-registration and wishes to remove an NCAGE code from their SAM.gov registration, the applicant should submit a help desk ticket ("incident") with the Federal Service Desk (FSD) online at www.fsd.gov using the following language: "I do not intend to seek financial assistance from the Department of Defense. Organizations based outside of the United States and that DO plan to do business with the DoD in addition to Department of State should follow the below instructions:

Exemptions

An exemption from the UEI and SAM.gov registration requirements may be permitted on a case-by-case basis. See <u>2 CFR 25.110</u> for a full list of exemptions.

Organizations requesting exemption from UEI or SAM.gov requirements must email the point of contact listed in the NOFO at least two weeks prior to the deadline in the NOFO providing a justification of their request. Approval for a SAM.gov exemption must come from the warranted Grants Officer before the application can be deemed eligible for review.

4. Submission Dates and Times

Applications may be submitted for consideration at any time before the closing date of *June 6, 2025*. No applications will be accepted after that date. Applications submitted by the deadline will be reviewed by July 15. Responses will be sent by August 15 subject to confirmation of the availability of funds.

5. Funding Restrictions

i. Funding Restrictions for the United Nations Relief and Works Agency (UNRWA)

None of the funds awarded resulting from this Notice of Funding Opportunity may be made available for subawards, direct financial support, or otherwise used to provide any payment or transfer to United Nations Relief and Works Agency (UNRWA).

ii. Certification Regarding Compliance with applicable Federal anti-discrimination laws

None of the funds awarded under this agreement may be used for any initiatives or programs, or any activities that do not comply with Executive Order 14173 titled Ending Illegal Discrimination and Restoring Merit-Based Opportunity.

By signing the SF-424 or SF-424I Application for Federal Assistance, the Applicant certifies the following:

F. Application Review Information

1. Review Criteria

Each application will be evaluated and rated based on the evaluation criteria outlined below.

- Organizational capacity and record on previous grants: The organization has expertise in its stated field and PD Poland is confident of its ability to undertake the program. This includes a financial management system and a bank account.
- Quality and Feasibility of the Program Idea: The program idea is well developed, with details about how program activities will be carried out. The proposal includes a reasonable implementation timeline.
- Goals and objectives: SMART goals and objectives are clearly stated, and the program approach is likely to provide maximum impact in achieving the proposed results.
- **Embassy priorities:** Applicant has clearly described how stated goals are related to and support U.S. Embassy Warsaw and Consulate General Krakow's priority areas and target audiences.
- Strength of American component: The extent to which the project will engage American experts/counterparts, create or strengthen ties between U.S. and Polish peer institutions, foster connections between Americans and Poles, or present American culture and society or best practices in an engaging manner.
- **Budget:** The budget justification is detailed. Costs are reasonable in relation to the proposed activities and anticipated results. The budget is realistic, accounting for all necessary expenses to achieve proposed activities.
- Monitoring and evaluation plan: Applicant demonstrates it can measure program success against key indicators and provide milestones to indicate progress toward goals outlined in the proposal. The program includes output and outcome indicators and shows how and when those will be measured.
- **Sustainability:** Program activities will continue to have a positive impact after the end of the program.

2. Review and Selection Process

A Grants Review Committee convened by PD Poland will evaluate all eligible applications. Please note that you may be asked to submit additional information and/or a revised budget in response to Committee deliberations.

3. Risk Review

i. Risk factors

Under the merit review as required by 2 CFR § 200.206, prior to making a Federal Award the Department will review and consider the following risk factors:

- a. Financial stability
- b. Management systems and standards
- c. History of performance
- d. Audit reports and findings

e. Ability to effectively implement requirements

G. Award Notices

The award or cooperative agreement will be written, signed, awarded, and administered by the Grants Officer. The award agreement is the authorizing document, and it will be provided to the recipient for review and signature by email. The recipient may only start incurring program expenses beginning on the start date shown on the grant award document signed by the Grants Officer.

If a proposal is selected for funding, the Department of State has no obligation to provide any additional future funding. Renewal of an award to increase funding or extend the period of performance is at the discretion of the Department of State.

Issuance of this NOFO does not constitute an award commitment on the part of the U.S. government, nor does it commit the U.S. government to pay for costs incurred in the preparation and submission of proposals. Further, the U.S. government reserves the right to reject any or all proposals received.

Unsuccessful applicants: Unsuccessful applicants will be notified by August 15, 2025 via email.

Payment Method:

Recipients will be required to request payments by completing form SF-270—Request for Advance or Reimbursement and submitting the form to the Grants Officer.

H. Post-Award Requirements and Administration

1. Administrative and National Policy Requirements

2. Reporting

Reporting Requirements: Recipients will be required to submit financial reports and program reports. The award document will specify what reports are required and how often these reports must be submitted.

Foreign Assistance Data Review: As required by Congress, the Department of State must make progress in its efforts to improve tracking and reporting of foreign assistance data through the Foreign Assistance Data Review (FADR). The FADR requires tracking of foreign assistance activity data from budgeting, planning, and allocation through obligation and disbursement. Successful applicants will be required to report and draw down federal funding based on the appropriate FADR Data Elements, indicated within their award documentation. In cases of more than one FADR Data Element, typically program or sector and/or regions or country, the successful applicant will be required to maintain separate accounting records.

I. Other Information

Guidelines for Budget Justification

Personnel and Fringe Benefits: Describe the wages, salaries, and benefits of temporary or permanent staff who will be working directly for the applicant on the program, and the percentage of their time that will be spent on the program.

Travel: Estimate the costs of travel and per diem for this program, for program staff, consultants or speakers, and participants/beneficiaries. If the program involves international travel, include a brief statement of justification for that travel.

Equipment: Describe any machinery, furniture, or other personal property that is required for the program, which has a useful life of more than one year (or a life longer than the duration of the program), and costs at least \$10,000 per unit.

Supplies: List and describe all the items and materials, including any computer devices, that are needed for the program. If an item costs more than \$10,000 per unit, then put it in the budget under Equipment.

Contractual: Describe goods and services that the applicant plans to acquire through a contract with a vendor. Also describe any sub-awards to non-profit partners that will help carry out the program activities.

Other Direct Costs: Describe other costs directly associated with the program, which do not fit in the other categories. For example, shipping costs for materials and equipment or applicable taxes. All "Other" or "Miscellaneous" expenses must be itemized and explained.

Indirect Costs: These are costs that cannot be linked directly to the program activities, such as overhead costs needed to help keep the organization operating. If your organization has a Negotiated Indirect Cost Rate (NICRA) and includes NICRA charges in the budget, attach a copy of your latest NICRA. Organizations that have never had a NICRA may request indirect costs of 15% of Modified Total Direct Costs as defined in 2 CFR 200.1.

"Cost Sharing" refers to contributions from the organization or other entities other than the U.S. Embassy. It also includes in-kind contributions such as volunteers' time and donated venues.

Alcoholic Beverages: Please note that award funds cannot be used for alcoholic beverages.
